PRIVACY STATEMENT

- The First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People Aboriginal Corporation RNTBC (PBC) will collect, use or disclose your personal information in accordance the PBC Privacy Policy and Privacy Procedures (see pccctrust.com.au).
- If the PBC does not collect this information from you we may not be able to determine your membership application or effectively communicate with you as a member;
- The PBC is a registered native title body corporate (RNTBC) registered under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (Cth) (CATSI Act) and authorised by the CATSI Act, *Native Title Act 1993* (Cth) (Native Title Act) and *Native Title (Prescribed Body Corporate) Regulations 2000* (Cth) (PBC Regulations) to collect personal information from individuals for determining your membership application, communicating with you as a member, meeting any other information requirements under these laws.
- The PBC may need to disclose the personal information collected in your membership application as required or authorised by law and to the following parties for the following purposes,:
 - PBC directors, officers and legal advisors for the purpose of determining your eligibility for membership.
 - Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda Elders for the purpose of providing a recommendation regarding your eligibility for membership.
 - The Office of the Regulator for Indigenous Corporations (ORIC) for the purpose of confirming the indigeneity of members of the PBC and meeting the requirements of the public register of corporations (members name and address).
 - Port Curtis Coral Coast Ltd (PCCC Ltd) and First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People Development Corporation Ltd (Development Corporation) to ensure that common law holders are able to be involved in relevant activities undertaken by these entities.
 - To any person who requests to view the PBC Register of Members (name and address).
- To ensure personal information collected, used, stored or disclosed is current and complete, the PBC Privacy Policy and Procedures (found at pccctrust.com.au) contains information on how you can request access to personal information held about you and how to seek correction of that information.
- It is not the intention of the PBC to disclose personal information to a person who is not in Australia or an external Territory. However, data collected via, for example, software applications may be stored overseas.
