CALLING FOR EXPRESSIONS OF INTEREST FOR DIRECTOR APPOINTMENT



Dear Gooreng Gooreng community members,

We are seeking expressions of interest (EOI) to nominate for the upcoming positions of Gooreng Gooreng Representative Directors on the Board of First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda Aboriginal Corporation RNTBC - ICN 8650 (the PBC)

The Gooreng Gooreng Directors have asked if we can assist with your Nomination and Election process again similarly to previous years which includes three simple steps;

1. Request for Nominations
2. Voting for Director
3. Director Appointment

Eligibility Criteria for appointment as a PBC Director includes the following:

- a) Must be at least 18 years old;
- b) Must be a member of PBC or eligible to be a member of the PBC;
- c) Must be nominated by the Gooreng Gooreng people;
- d) Must have or have applied for a Directors Identification Number.

Term of Office - PBC Directors have a terms of 2 years.

Selection and Appointment Process

To select new Gooreng Gooreng Representative Directors for the PBC Board, individuals can nominate themselves by submitting the completed forms to Returning Officer Dillon Bowers Lawyers by Monday 16 December 2024. After nominations close, a Ballot Paper listing eligible nominees will be sent to the Gooreng Gooreng community for voting. The Returning Officer will handle the voting process.


